A) PREAMBLE: -

E) SCOPE: -

This MoU details the modalities and general conditions regarding collaboration between Shri Shivaji science college, Amravati and Core Project Engineers & Consultant Private Limited, Amravati, for enhancing the availability of highly qualified manpower in the areas of Environmental Science without any prejudice to prevailing rules and regulations in Environmental Science Program of Shri Shivaji science college, Amravati, and Core Project Engineers and Consultant Private Limited, Amravati The areas of cooperation can be extended through mutual consent.

F) ROLES & RESPONSIBILITIES: -

Both Environmental Science Department of Shri Shivaji science college, Amravati, and Core Project Engineers & Consultant Private Limited, Amravati shall encourage interactions between the Engineers, faculty members and students of both the organizations through the following arrangements:

- a) Exchange of personnel through deputation for special subject/s as per consent of authorities of both parties.
- b) Organization of joint conferences and seminars, Industrial visits, Expert Talks, etc Monitor process of organizing industry based projects for U.G. and P.G. students.
- c) Conduction of practical training for faculty of Environmental Science Department of Shri Shivaji science college, Amravati, students and Core Project Engineers & Consultant Private Limited, Amravati
- d) Running of newly designed course/s suitable to both the organizations to enhance quality and performance. Such Courses maybe run at any one place with mutual consent.
- e) Assisting & guiding engineers, employees, faculty members and students of both the organizations in introducing, modifying existing process, modernization, trouble shooting, etc.
- f) Arranging discussion sessions for the faculty members and students of the institute to design its curriculum as well as introducing various certificates and diploma courses for the requirement of Core Project Engineers and Consultant Private Limited, Amravati

J) VALIDITY TERMS: -

This MoU shall be valid for a period of 05 years (Five) from date of signing with time to time evaluation by decision making authorities or advisory committee, if needed. The proposal can be continued after 05 years (Five) with mutual understanding for any length of term.

Following conditions are specified to terminate the MoU.

- 1) Breach of trust from either side.
- Objection of Government due to any policy change.
- 3) Insisting to develop any technological impossible project.
- 4) Non committal attitude from either side.
- 5) Any other issue with mutual consent.
- 6) Activities of MoU should not affect in any way teaching learning process.

K) EXPECTED OUTCOMES: -

By way of implementation of this MoU, both the organizations will be benefitted with updating & conversant of new technologies.

L) SPECIAL TERMS: -

The important clauses of MoU are arbitrations will be

Safety: - Both the parties will not be responsible for an incidence occurred due to non safety process. All safety norms of quality of standards will be

maintained while executing the activities under MoU. Legal: - Any dispute arising about any aspects of MoU shall be settled through mutual consultation and agreement by the parties of this MoU. In case a settlement is not arrived at dispute, will come under the preview. There will not be any financial aspect involved for activity as non profit asset development. No violation of any Indian Act.

This MoU shall be constructed and governed by Laws of India. Any controversy or claim arising out of or related to this MoU or breach those of shall be settled by arbitration to be held in Mumbai as in accordance with the rules of Arbitration and Conciliation Act 1996.

Confidentiality and intellectual property rights will be perfectly maintained for efforts under this MoU.

MoU will be reviewed after every six months for any necessary modifications needed for smooth functioning and achieving objectives with mutual consent of partners and due approval with the Government.
