This memorandum of association between Shri Shivaji Science College, Amravati (hereafter 'Science College') and Shri Shivaji College of Horticulture, Amravati (hereafter 'Horticulture College') is to collaborate and provide academic and research assistance to the Graduates and Post Graduate students of both the colleges. Both the institutions are agreed to lend hands in following events –

2. Interdisciplinary research projects will be perceived in collaboration of teachers and students of both the institutes.
3. The infrastructural facilities will be extended to the research and academic ventures.
4. Project proposal for financial assistance to any event will be prepared and submitted to the funding agencies.

Terms and conditions:

It is binding for both the institutions that:

- i. Activities should be planned in mutual understanding
- ii. Activities must be planned for the benefit of students' fraternity.
- iii. The financial gain should not be the objective of any activity.
- iv. Equipments purchased in the collaborative project must be retained as asset of the proposer of the activity.
- v. The submission of the final technical reports in the case of the funded proposal will lie on the proposer of the activity.
- vi. The resource persons from both the institutions should contribute without remuneration.
- vii. The facilities available with both the institutions must be made accessible for the activity without any charge.

This memorandum of association shall be in force from the date of its signing by both institutions and shall remain in effect until termination of this agreement at any point of time, by either of the institutions. The termination of this understanding will require notice in six (6) months advance to the other institution



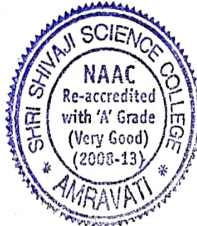
