This notice is being issued for Online Registration, Scanning & uploading of documents, Documents E- Verification and Online Application Form Confirmation, Filling & Confirmation of Option Form, Self-confirmation before seat acceptance, Paying seat acceptance fees in online mode for confirmation of admission, reporting to Institutes by candidates aspiring for admissions to First Year of Three/Four Year Full Time Under Graduate Course in BCA/ First Year of Four Year Full Time Under Graduate Course in MCA (Integrated) in the Government, Government Aided, University Managed, University Departments and Unaided Private Professional Educational Institutions for the Academic Year 2025-26 in the Maharashtra State.

For the purpose of document verification, the concept of E-Scrutiny of the documents is introduced by the Competent Authority. The candidate shall choose E-Scrutiny mode for document verification during online form filling.

Process of application: The Candidate shall register online, fill & submit online application form and upload the required documents from anywhere through the computer connected to internet for verification and confirmation of the application form, his/her application & documents shall be verified and confirmed by the designated E-Scrutiny Center through online mode.

- 1. All types of candidates aspiring for admission under CAP seats shall register himself/herself online, Scan and upload Documents, solve grievances (Depends on document verification mode selected by candidate) raised by Scrutiny Center (SC) in person or raised by E-Scrutiny Center during E-Verification verified documents & Application Form confirmed by E-Scrutiny Center. Such eligible registered candidates shall be considered for CAP Merit and admission through CAP.
- 2. In case of Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant candidates should send the print of online filled & submitted application form & copy of uploaded documents by hand/speed post/courier for verification & confirmation to "Director, Sardar Patel College of Engineering (SPCE), Versova Road, Munshi Nagar, Andheri (West), Mumbai- 400058" shall approach directly to the Institute for admission where such quota is granted by the appropriate authority.
  - 3. The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is <u>Mandatory</u> to get registered, documents verified and confirmation of application by the Scrutiny Center. After registration, such candidates must apply separately to Institutes for admissions to seats other than CAP Seats (Non-CAP Seats). Merit of such candidates shall be prepared by the Institute at the institute level.

#### Important Instructions for Candidates:

- 1. Candidates has to resolve the discrepancies marked, if any, in her/his CAP application during the document verification process within the given timeline. If candidates fail to confirm online filled application form at E-Scrutiny center or Physical Scrutiny Center, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for both CAP as well as Institute Level admission process.
- 2. The candidates belonging to SC, VJ/DT (NT (A), NT (B), NT(C), NT (D), OBC, SBC and SEBC categories shall produce "Caste Validity Certificate" and ST category shall submit "Tribe Validity Certificate". All Backward Class candidates excluding SC & ST shall produce Non Creamy Layer certificate valid up to 31st March 2026. If such candidates fail to produce the original certificate or receipt of Caste/Tribe validity certificate, Non Creamy Layer certificate and EWS certificate issued by competent authority at the time of verification by Scrutiny Center, then such candidates will be treated as GENERAL category candidates for CAP admissions.
- 3. EWS candidates shall produce the Eligibility Certificate for Economically Weaker Section (As per the format in Maharashtra State Government Resolution No. राआधी-4019/P.N.31/16-अ, dated 31/05/2021 only). Refer Proforma V of Information Brochure for AY 2025-2026.
- 4. In case of Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant Candidates after registration & confirmation of their application at "Director, Sardar Patel College of Engineering (SPCE), Versova Road, Munshi Nagar, Andheri (West), Mumbai- 400058" shall approach directly to the Institute for admission where such quota is granted by the appropriate authority.
- 5. For Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant

- Candidates: Such Candidates will get the Receipt-cum-Acknowledgement through their login after confirmation of application by Scrutiny Center. Applications received after the last date from candidates belonging to Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant candidates will be summarily rejected and no correspondence will be entertained in this regard.
- 6. Candidates who have registered as a reserved category candidate, but unable to produce required certificate for reservation claim during documents verification stage shall have to pay difference of fee of Rs. 200/- through online mode only.
- 7. Once the candidate confirms his/her Option form online through his/her Login for the respective admission rounds, Candidate will not be allowed to change/cancel the option/preference submitted under any circumstances.
- 8. A Candidate who has been allotted a seat shall download the "Provisional Seat Allotment Letter".
- 9. The Seat Acceptance Fee shall be Rs. 1,000/- for all Candidates. The candidate has to pay the Seat Acceptance Fee during first seat acceptance only. This fee shall be treated as non-refundable processing fee. The Seat Acceptance fees is to be paid through His/ Her Own login by ONLINE MODE only.
- 10. Seat will be confirmed by the allotted institute after verification of the original documents and ensuring that the Candidate meets all the eligibility norms. The admission in-charge of institute shall issue the Online Receipt of admission confirmation to the candidate.
- 11. - 14. The EWS Candidates who submitted receipt of EWS Certificate during registration, physical document verification and confirmation period should upload and verify original EWS Certificate as per Proforma-V of the information brochure at Scrutiny Center and submit original certificate to the admitted institute on or before last day of reporting of CAP round 4, up to 5.00 PM, otherwise these candidates admission will get automatically cancelled and shall be considered as Open category candidates for next institute level round provided candidate fulfill eligibility criteria for open category.

  - b. For an Open-EWS Category candidate: Convert from Open-EWS Category to Open Category (Non-EWS).
- 16. If a candidate chooses to convert to the Open Category, the following scenarios are possible:
  - a. If a candidate has already been allotted a seat in CAP Round I, II, or III by availing the benefits of the Reserved Category or EWS, their allotted seat will be cancelled. They will then be considered under the Open Category/Non-EWS for CAP Round IV.
  - b. If a candidate has not availed the benefits of the Reserved Category or EWS in CAP Round I, II, or III, their previously allotted seat will be retained. They will be considered under the Open Category/Non-EWS for CAP Round IV.

- All types of candidates aspiring for admission under CAP seats shall register himself/herself
  online, Scan and upload Documents, solve grievances (Depends on document verification mode
  selected by candidate) raised by Scrutiny Center (SC) in person or raised by E-Scrutiny Center
  during E- Verification verified documents & Application Form confirmed by E-Scrutiny
  Center. Such eligible registered candidates shall be considered for CAP Merit and admission
  through CAP.
- 2. In case of Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant candidates should send the print of online filled & submitted application form & copy of uploaded documents by hand/speed post/courier for verification & confirmation to "Director, Sardar Patel College of Engineering (SPCE), Versova Road, Munshi Nagar, Andheri (West), Mumbai- 400058" shall approach directly to the Institute for admission where such quota is granted by the appropriate authority.
- 3. The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is <u>Mandatory</u> to get registered, documents verified and confirmation of application by the Scrutiny Center. After registration, such candidates must apply separately to Institutes for admissions to seats other than CAP Seats (Non-CAP Seats). Merit of such candidates shall be prepared by the Institute at the institute level.

#### > Important Instructions for Candidates:

- 1. Candidates has to resolve the discrepancies marked, if any, in her/his CAP application during the document verification process within the given timeline. If candidates fail to confirm online filled application form at E-Scrutiny center or Physical Scrutiny Center, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for both CAP as well as Institute Level admission process.
- 2. The candidates belonging to SC, VJ/DT (NT (A), NT (B), NT(C), NT (D), OBC, SBC and SEBC categories shall produce "Caste Validity Certificate" and ST category shall submit "Tribe Validity Certificate". All Backward Class candidates excluding SC & ST shall produce Non Creamy Layer certificate valid up to 31st March 2026. If such candidates fail to produce the original certificate or receipt of Caste/Tribe validity certificate, Non Creamy Layer certificate and EWS certificate issued by competent authority at the time of verification by

- Scrutiny Center, then such candidates will be treated as GENERAL category candidates for CAP admissions.
- 3. EWS candidates shall produce the Eligibility Certificate for Economically Weaker Section (As per the format in Maharashtra State Government Resolution No. राआधो-4019/P.N.31/16-अ, dated 31/05/2021 only). Refer Proforma V of Information Brochure for AY 2025-2026.
- 4. In case of Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant Candidates after registration & confirmation of their application at "Director, Sardar Patel College of Engineering (SPCE), Versova Road, Munshi Nagar, Andheri (West), Mumbai- 400058" shall approach directly to the Institute for admission where such quota is granted by the appropriate authority.
- 5. For Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant Candidates: Such Candidates will get the Receipt-cum-Acknowledgement through their login after confirmation of application by Scrutiny Center. Applications received after the last date from candidates belonging to Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant candidates will be summarily rejected and no correspondence will be entertained in this regard.
- 6. Candidates who have registered as a reserved category candidate, but unable to produce required certificate for reservation claim during documents verification stage shall have to pay difference of fee of Rs. 200/- through online mode only.
- 7. Once the candidate confirms his/her Option form online through his/her Login for the respective admission rounds, Candidate will not be allowed to change/cancel the option/preference submitted under any circumstances.
- 8. A Candidate who has been allotted a seat shall download the "Provisional Seat Allotment Letter".
- 9. The Seat Acceptance Fee shall be Rs. 1,000/- for all Candidates. The candidate has to pay the Seat Acceptance Fee during first seat acceptance only. This fee shall be treated as non-refundable processing fee. The Seat Acceptance fees is to be paid through His/ Her Own login by ONLINE MODE only.
- 10. Seat will be confirmed by the allotted institute after verification of the original documents and ensuring that the Candidate meets all the eligibility norms. The admission in-charge of institute shall issue the Online Receipt of admission confirmation to the candidate.
- 11. The SC, ST, VJ/DT, NT(A), NT(B), NT(C), NT(D) and SBC Candidates who submitted receipt of Caste/Tribe Validity Certificate, Non Creamy Layer Certificate during registration, physical document verification and confirmation period should upload and verify original Caste/ Tribe Validity Certificate, Non Creamy Layer Certificate at Scrutiny Center and submit original certificate to the admitted institute on or before last day of reporting of CAP round 4, up to 5.00 PM, otherwise these candidates admission will get automatically cancelled and shall be considered as Open category candidates for next institute level round provided candidate fulfill eligibility criteria for open category.
- 12. In case of SEBC and OBC Candidates timeline for submission of original Caste Validity Certificate document against the receipt will be as per the government G. R. शा. नि. क्र. संकीर्ण २०२५/प्र. क्र. ६८/आरक्षण -५ दि. २६/०८/२०२५ (click here for G.R.)
- 13. The SEBC and OBC Candidates who submitted receipt of Non Creamy Layer Certificate during registration, physical document verification and confirmation period should upload and verify original Non Creamy Layer Certificate at Scrutiny Center and submit original certificate to the admitted institute on or before last day of reporting of CAP round 4, up to 5.00 PM, otherwise these candidates admission will get automatically cancelled and shall be considered as Open category candidates for next institute level round provided candidate fulfill eligibility criteria for open category.
- 14. The EWS Candidates who submitted receipt of EWS Certificate during registration, physical document verification and confirmation period should upload and verify original EWS Certificate as per Proforma-V of the information brochure at Scrutiny Center and submit original certificate to the admitted institute on or before last day of reporting of CAP round 4, up to 5.00 PM, otherwise these candidates admission will get automatically cancelled and shall be considered as Open category candidates for next institute level round provided candidate fulfill eligibility criteria for open category.
- 15. Before proceeding with the CAP Round 4 option form, if it is likely that a candidate will be unable to produce the original CVC/TVC, EWS, or NCL document within the given timeline, they should consider the following optional facility to convert their candidature type:

- a. For a Reserved Category candidate: Convert from Reserved Category to Open Category.
- b. For an Open-EWS Category candidate: Convert from Open-EWS Category to Open Category (Non-EWS).
- 16. If a candidate chooses to convert to the Open Category, the following scenarios are possible:
  - a. If a candidate has already been allotted a seat in CAP Round I, II, or III by availing the benefits of the Reserved Category or EWS, their allotted seat will be cancelled. They will then be considered under the Open Category/Non-EWS for CAP Round IV.
  - b. If a candidate has not availed the benefits of the Reserved Category or EWS in CAP Round I, II, or III, their previously allotted seat will be retained. They will be considered under the Open Category/Non-EWS for CAP Round IV.
  - c. Candidates who have not been allotted any seat up to CAP Round III and are aware that they will be unable to produce the original CVC/TVC, NCL, or EWS certificate within the given timeline, can convert themselves to the Open Category/Non-EWS. These candidates will remain eligible for allotment in CAP Round IV under Open Category/Non-EWS seats.
- 17. Once a candidate converts from Reserved Category to Open Category or from EWS to Non-EWS, they will only be considered for allotment in the fourth CAP round and institutional rounds under the Open Category/Non-EWS.
- 18. A candidate who has converted to the Open Category/Non-EWS will not be permitted to revert back to the Reserved Category/EWS.
- 19. The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is Mandatory to get registered, documents verified and confirmation of application by the Scrutiny Center. After registration, such candidates must apply separately to Institutes for admissions to seats other than CAP Seats. Merit of such candidates shall be prepared by the Institute at the institute level.
