Art. 1

This Agreement/Linkage sets out the purpose, terms and conditions of MOU between Shri Shivaji
 Science College, Amravati

Art. 2

This agreement pertains to teaching, research, and student exchange /internship.

Art. 3

Both the organization agree on the following forms of cooperation:

In the field of Education:

- to exchange experience in teaching methods.
- · to exchange staff members for the purpose of giving lectures, taking part in seminars etc.

In the field of Research:

- to conduct joint research projects / coordinate research studies.
- to organize joint seminars, conferences, symposia etc.

In the field of Student Exchange:

- to create conditions enabling students to take up master's, Ph.D. or postgraduate studies at the partner institution being a party of this agreement.
- to create/deploy students for a period of one semester of its part, or for a time needed to conduct specific project/survey, practical training, or preparation of thesis,
- · to carry out joint research programs by students,
- to deploy students for practical training/internship as per New Education Policy-2020.

In the field of Consultancy:

- · to provide analytical services, exchange of technologies,
- to conduct Academic/Environmental and Energy Auditing an opportunity for making use of the tangible and intangible resources available with the university.

Art. 4

• To achieve specific objectives and tasks under this Agreement, the internal organizational units shall design a detailed working plan. This plan shall refer to this Agreement and shall provide for the rules of cooperation such as, time and period of the parties 'representatives' visits, use of analytical facilities available in the university, financial obligations if any, protection of intellectual property rights etc.

Art. 5

- The parties agree to take necessary steps, ensuring mutual support for the purpose of meeting the objectives of MOU, collaboration / linkages.
- This agreement does not entail any financial consequences for either of the parties.

Art. 6

- This Agreement centers into force on the day of its signature and will be valid for 5 years.
- If the parties, at least 6 months before expiration of this period, do not initiate the process to extend it, this Agreement would stand terminated.
- The Agreement can be terminated with a prior written notice of termination submitted by the 30th of June of the given year with effect at the end of that academic calendar year.
- All amendments to this Agreement are null and void unless made in writing.

• This Agreement has been two counterparts - one for each party.
