

MEMORANDUM OF UNDERSTANDING CONTROL SEC 2022 SHRI SHIVAJI SCIENCE COLLEGE, DEPARMENT OF ENVIRONMENTAL SCIENCE AMRAVATI

AND

RATTANINDIA POWER LTD, A THERMAL POWER PROJECT, NANDGAONPETH MIDC, AMRAVATI, MAHARASHTRA, INDIA

This Memorandum of Understanding (MOU) sets for the term and understanding between Shri Shivaji Science College Amravati, Department of Environmental Science and Rattanindia Power Ltd, a Thermal Power Project at Nandgaonpeth MIDC, Amravati, Maharashtra, India to work in co-ordination on certain mentioned actives for betterment of environment and as an Institutional Social Responsibility.

# A. PREAMBLE:

RATTANINDIA POWER LTD (RPL), a company registered under the Companies Act, 1956 havings its thermal power project at plot no. D2 & D2 (Part), Addl Industrial Area, Nandgaonpeth MIDC, Amravati, Maharashtra, India 444901 hereinafter referred to as "RPL" which expression unless it be repugnant to the context or meaning thereof be deemed to mean that and include its successors and assigns, executing this MOU through its authorized signatory Mr. Sedhu Madhavan of One Part;

AND

SHRI SHIVAJI SCIENCE COLLEGE AMRAVATI evolved under Shri Shivaji Education Society as a premier institute for imparting formal education in science stream and affiliated to Sant Gadge Baba Amravati University, Amravati, Maharashtra, India. The college has been re-accredited with "A+" Grade with C.G.P.A. of 3.42 in 2022 by NAAC, Bangalore. The University Grand Commission (UGC) HAS AWARDED THE STATUS OF THE College with Potential for Excellence (CPE). The department of Environmental Science was established in 1999. The department conducted extension programmes such as Noise Pollution Monitoring, PUC Camp, promotion of Environmental Awareness, Microbiological Testing of Water Samples, Study of Heavy Metals in Ground Water. The Central Instrumentation Centre (C.I.C.) of the college has the facilities to carry out various analytical and spectroscopic measurements, chromatography and sample characterization by visual and photographic analysis. The C.I.C. has state of the art analytical facilities.

#### **B. OBJECTIVE:**

The objectives of this Memorandum of Understanding:

- > To promote interaction between Shri Shivaji Science College, Amravati and Rattanindia Power Ltd, a Thermal Power Project, Nandgaonpeth MIDC, Amravati in mutually beneficial areas to benefit the students such as
- > Upcoming technologies in the principal technical and research areas.
- Sharing knowledge and capability in the concern area for mutual benefits and become trusted partners in the area of knowledge enrichment.
- To provide a formal basis for initiating interaction between SSSC and RPL.
- > To conceptualize the project to be executed in collaboration on need basis.

> To share information and technology to develop the required skills and intend to create a center of excellence to support this collaborative effort.

# C) PROPOSED MODES OF COLLABORATION:

Shri Shivaji Science college, Amravati and Rattanindia Power Ltd, propose to collaborate through

- Conducting Continuing Education programs, Capability development of the students, Workshops, Conclave, Seminars, Events, Expert Talks etc.
- Provide selected students with a formal training program or specific training.
- Conducting yearly placement drive for UG and PG college student, depending on suitable vacancy at the Amravati Plant.
- > Provide internship for college students, as per management approval of Rattanindia Power Ltd.
- Provide guidance and support to PG student for completion of their project work.
- Provide permission to visit its Thermal Power Project at Nandgaonpeth MIDC, Amravati subject to compliance of all safety norms and compliances under Factories Act.
- > Sampling and analysis of water, air, noise sample in Environment science department consultancy and college Central Instrumentation Center.

## D) FINANCIAL TERMS:

- ➤ The collaboration program between Environmental science Department of Shri Shivaji science college, Amravati and Rattanindia Power Ltd, Nandgaonpeth MIDC, Amravati shall be coordinated by a coordinating committee appointed by both the organizations.
- > This MOU does not base on any economical commitment from both parties.

### **E) VALIDITY TERMS:**

This MoU shall be valid for a period of 05 years (Five) from date of signing with time-to-time evaluation by decision making authorities or advisory committee' if needed. This MOU can be extended after a period of 5 years (Five) with mutual understanding.

#### F) TERMINATION:

Following conditions are specified to terminate the MOU.

Breach of trust from either side

- 3. Non-committal attitude from either side
- 4. Any other issue with mutual consent.
- 5. Activities of MOU should not affect in any way teaching learning process.
- Any dispute arises between the parties shall be tried to settle between the parties with mutual discussion. This MOU is subject to jurisdiction of Courts at Amravati.

If any party found in breach of any of the terms of this MOU, the MOU shall stands terminated with immediate effect.

#### I) ASSIGNMENT:

This MOU shall not be assigned or otherwise transferred by any party, in whole or in part, without the express written consent of other party.

## J) AMENDMENT:

No amendment to this MOU shall be valid and binding to the parties unless it is made in writing and signed by authorized representative of all parties to this MOU.
