This Memorandum of Understanding (MOU) sets for the term and understanding between Shri Shivaji Science College Amravati, Department of Environmental Science and SIMAK IT PVT.

A. PREAMBLE:

- SIMAK IT PVT. LTD. Amravati would accommodate students who have completed the 1st semester of their programmed in such a number that SIMAK IT PVT. LTD. Amravati deems convenient to it for the purpose of imparting industrial training.
- Research student also can avail the facility to complete their work.

D) FINANCIAL TERMS:

- The collaboration program between Environmental science Department of Shri Shivaji science college, Amravati and SIMAK IT PVT. LTD. Amravati shall be coordinated by a coordinating committee appointed by both the organizations.
- This MOU does not base on any economical commitment from both parties.

E) VALIDITY TERMS:

This MoU shall be valid for a period of 05 years (Five) from date of signing with time to time evaluation by decision making authorities or advisory committee' if needed.

During its tenancy, the MOU may be extended or terminated by a prior notice of not less than ONE months by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty who have been admitted to pursue a programme under the MOU.

The proposal can be conditions after 5 years (Five) with mutual understanding' Following conditions are specified to terminate the MOU.

- 1) Breach of trust from either side
- 2) Objection of Government due to any policy change
- 3) Insisting to develop any technological impossible project
- 4) Non-committal attitude from either side
- 5) Any other issue with mutual consent.
- 6) Activities of MOU should not affect in any way teaching learning process.
