GENERAL TERMS & CONDITIONS

Date: 05.01.2025

1. Sealed tenders are invited from authorized dealers/manufacturers for the supply of Laboratory glassware/ plastic ware / chemicals/ Teaching kits/other for rate contract up to March-2025.
2. The completed tenders should be submitted in inward section of Shri Shivaji Science College, Amravati on or before due date and time.
3. Tenders duly filled in will be accepted on or before 16/01/2025 up to 15.00 Hrs. and will be opened on 16/01/2025 at 16.00 hrs. in the presence of tenderers & purchase committee.
4. The college will not be responsible for postal delay, non receipt of tender documents.
5. The tenderer should submit tender in two bid envelope system.
(a)Envelope No.1 should contain following documents.
 - i) Demand Draft/Banker's cheque of Rs.500/- (in case of e-tender form downloaded from website) in favor of the Principal, Shri Shivaji Science College, Amravati.
 - ii) Copy of GST registration
 - iii Copy of shop act registration
 - iv) Copy of authorization letter from manufacturer. (Original authorization letter will be verified if required)
(b)Envelope no.2 should contain price offer.
6. Tenders not in conformity with our prescribed specifications, terms & conditions will be rejected. College has right to reject/accept any or all tenders without assigning any reasons.
7. Rates should be valid up to 31.03.2025 from the date of approval, and F.O.R. college Including all taxes (i.e.GST etc.), Installation/ transportation etc.

8. The supplier shall supply the ordered goods within the period mentioned in the order failing which College will take strict action against the supplier.
9. The supplier has to pay EMD of Rs. 5000/- in the form of Demand draft / Bankers cheque in favor of the Principal, Shri Shivaji Science College, Amravati at the time of agreement.
10. In the event of failure to comply with the supply of materials the EMD will be forfeited. Similarly if supplier fails to supply the goods in time, college will be at liberty to purchase the ordered goods from the open market without giving any prior notice & if compelled to purchase at the higher price than your approved rates such losses shall be recovered from the EMD or any outstanding payment of the tenderer.
